- **001. Invitation:** The Chair opened the meeting and thanked the Councillors and members of the public for their attendance.
- **002. Apologies for Absence:** Apologies were received and accepted from WNC Cllr. Nick Sturges-Alex
- 003. Declarations of Interests: None.

#### 011. Resolutions and Decisions:

- 1)Spring Newsletter-presentation: The Chair presented a copy of the Newsletter and thanked all the volunteers for helping in its distribution.

# 012. Reports from the Councillors and Clerk:

- 1). Environmental Issues:
  - i) Flood Innovation Project: Awaiting response from WNC.
  - ii) Football Pitch: Awaiting response from Prologis.
  - iii) Plants project: The Chair reported that the wild flower seeds which were to be supplied by Idverde has not happened and that the Parish Council should purchase these and plant in the areas designated within Hunsbury Meadows. This was approved.
- 2) Community Cohesion Report: The survey undertaken with the Newsletter identified two of the residents needing help. It was agreed that the search should continue. The Chair thanked the volunteers for their help.
- 3) Allotments: Idverde informed the clerk that they allocate vacant plots in existing allotments but could not help regarding allocation of new land for allotments.
- 4) Party in the Park: Cllr. Hudson reported that the preparation is on track and that new banners should be ordered soon.
- 5) Pineham Village activity: Cllr. Lloyd reported that a residents around The green rejected an idea of tall nets. However, playing of football on the green has become very emotive subject.
- 6) Notice boards and Brass Plates: Size of the notice boards was confirmed and purchase of one notice board approved.

  Purchase of one additional Brass plates was also approved..
